**NOTICE IS HEREBY GIVEN** that at the meeting of the Oversight Board (the “Oversight Board”) of the Successor Agency to the Manteca Redevelopment Agency (the “Successor Agency”) to be held on January 24, 2017, at 2:00 P.M., or as soon thereafter as possible, the Oversight Board will consider the adoption of a resolution directing the conveyance to the City of Manteca (the “City”) of four governmental use properties pursuant to the Successor Agency’s Long-Range Property Management Plan, as amended and approved by the California State Department of Finance. Such four properties include: (i) Property No. 5, a public parking lot at 123 S. Grant Avenue (APN: 221-020-35), (ii) Property No. 6, a vacant lot at 2260 W. Yosemite Avenue (APN: 241-300-06), (iii) Property No. 7, a storm water retention basin at 2470 Daniels Street (APN: 241-530-03), and (iv) Property No. 8, a public transit station located at 220 Moffat Boulevard (APN: 221-030-25).
